

# Foreign Policy

of the Earth Federal Republic

Approved with unanimity of the Earth Republic citizens participating in the General Assembly of 5 August 2017

### Preamble

In order to defend the unity between nations and the fraternity of all people, the Earth Federal Republic is open to establish formal or informal relations with other nations, specially those which share similar values. As provided by the Constitution, article 15.2, all treaties must be ratified by the General Assembly and signed by the National Government.

## Chapter I: Modalities of relation

#### **Article 1: Unilateral recognition**

- (1) An unilateral recognition consists in the recognition of a nation by the Earth Republic without that nation signing a treaty.
- (2) An unilaterally recognised nation may apply for a bilateral recognition (see article 2) at any moment. In this case, a ratification from by the General Assembly is not needed.
- (3) The General Assembly decides case-by-case what nations should be unilaterally recognised.

#### **Article 2: Bilateral recognition**

- (1) A bilateral recognition consists in a treaty signed by the Earth Republic and other nation in which both nations recognise each other as sovereign countries or nations.
- (2) The Earth Republic will only accept treaties of bilateral recognition with nations that meet the following standards:
  - a) The nation must have two or more citizens.
  - b) It must have existed for two weeks or more.
  - c) Its laws must not enter in conflict with the values, rights and freedoms recognised in the Earth Republic Constitution.

#### **Article 3: Mutual assistance**

- (1) A mutual assistance treaty ensures the collaboration between the Earth Republic and another nation in order to help each other developing various aspects of the nation.
- (2) This modality of relation implies a bilateral recognition.
- (3) An ambassador of the other nation shall have access to all of the official communication channels.
- (4) An ambassador of the Earth Republic shall have access to the official communication channels of the other nation.
- (5) All standards for a bilateral recognition apply for a mutual assistance treaty, together with:
  - a) The nation must have a democratic political system.
  - b) The constitution or legislation of the nation, as well as the actions of the government, must reflect a respect for human rights and all rights defined in the Chapter IV of the Earth Republic Constitution.
  - c) The nation must not be in conflict with any other nations that have signed a mutual assistance treaty.

#### Article 4: Non-aggression and protection treaties

- (1) The Earth Republic does not have an army at its disposal. Therefore, any proposal for a non-aggression treaty will not be accepted.
- (2) For the same reason, the Earth Republic will not sign any treaty that implies the military protection of another nation.

#### **Article 5: International organizations**

(1) The Earth Republic will only be part of organizations that do not enter in conflict with the Constitution, including the moral values and rights described in it.

## Chapter II: Proceedings

#### **Article 6: Unilateral recognition**

- (1) Any citizen participating in the General Assembly, including a National Minister or the National President, can propose a nation to be unilaterally recognised.
- (2) The absolute majority of the citizens participating in the General Assembly is needed in order to approve the motion.
- (3) If the motion is approved, the Ministry of National Representation will notify the recognised nation by email.

#### Article 7: Bilateral recognition and mutual assistance

- (1) Any citizen participating in the General Assembly, including a National Minister or the National President, can propose to sign a treaty of bilateral recognition or mutual assistance with another nation.
- (2) If there is absolute majority supporting the treaty, the Ministry of National Representation must send a copy of the treaty to the Government of the Nation.
- (3) If the other nation accepts and signs the treaty, the General Assembly must ratify the treaty in order to confirm it.
- (4) If the Ministry of National Representation receives a proposal to sign a treaty, the General Assembly must approve it before it is signed.
